The Director stated that his Military Duty was scheduled March 19, 2020 – July 31, 2020 as of this date.

b. COVID Reimbursement

The Deputy Director stated that the combined April/March totals for staffing expense was \$1.863 million. For the month of May it was \$1.131 million. She stated that it was a combined total of \$2.994 million dollars. She stated that the supply expense was \$682,500 for March/April. The May expense was \$178,000 for a combined total of \$860,620. The Deputy Director stated that the meal expense for staff was \$54,000 for the month of May. The combined expense for March/April was \$84,000, bringing the overall total to just shy of \$139,000. She stated that the agency has paid \$1,000 in financial hardship requests. She stated that the total application for reimbursement at this time was \$3.995 million dollars in total COVID related expenses.

The Director of Homes stated that on Friday, June 12th the Governor had released an update to his executive order stating that on June 15th long term care facilities were going to be able to accept visitation. He stated that the ODVA had broken the visitation availability for each facility up into three phases. He stated that the Sulphur, Talihina, and Clinton facilities were currently in phase 3 and allowing visitation following CDC guidelines.

The Director of Homes stated that as of today's date, as an agency we have seen nine positive cases of COVID-19 from eight Residents. One Resident has tested positive twice. There have been seven employees with COVID-19 positive results.
